Bike Rental Insurance

Insurance is available for purchase on all Cycle Europe bicycle rentals

The insurance will cover the cost of repairs and/or bike parts to be replaced in the case of damage or accident. Compensation in the case of theft of an unattended bike applies only if and when the bike has been locked, and a report has been filed with local police authorities. Customers that have purchased bike insurance and that experience damage or theft of their bike will receive telephone support from Cycle Europe staff, as may be needed.

Please select and pay for the insurance that best suits your needs at the time of booking. The prices are based on type of bike and number of rental days:

E-bikes, Tandem bikes, Gravel Titanium bikes (price per bike):

- 1-5 days €25
- 6-8 days €30
- 9-12 days €35
- 13-20 days €50
- 21+ days please inquire

€250 **Deductible** (if a claim is made, the deductible must be paid by the customer in order for the insurance benefit to take effect)

Premium titanium bikes, Aluminum bikes, Hardtail Mountain Bike (price per bike):

- 1-5 days €15
- 6-8 days €20
- 9-12 days €25
- 13-20 days €30
- 21+ days please inquire

€150 Deductible (if a claim is made, the deductible must be paid by the customer in order for the insurance benefit to take effect)

If purchased at the time of delivery, a €10 booking fee per bike is applied

<u>Please note:</u> In the case of theft or damage, the insurance benefit does not include or consider the cost of providing the customer with a new rental bike during the days remaining until the end of their tour or rental service. Cycle Europe will attempt to provide a new rental bike for a customer that desires to finish their tour or rental service, in which case the customer will be responsible for the rental hire cost for these additional days (including delivery/collection costs, if applicable).
